NEW QR CODES AT THE LAW LIBRARY

A QR code®, or Quick Response code, is a two-dimensional barcode containing various types of encoded information that is readable by smart phones. To make use of this technology, your phone must be capable of capturing the code with special barcode scanners, which can be found on the Internet (just Google 'qr scanner').
