The Law Library has been able to offer remote access to *Westlaw* for many months during the pandemic. *Westlaw's* offer is still the same, but *Lexis* recently changed its offer. Since these offers could end at any time, please take advantage of them while they are still available.

Westlaw is continuing to offer Cleveland Law Library members temporary free remote access to Westlaw for a trial period of 20 hours of usage over 14 days. Content includes primary law, secondary sources, litigation, and Practical Law on the Westlaw Classic platform. ## WESTLAW LEGAL ANALYTICS CAPABILITIES

Legal statistics on judges, courts, lawyers, law firms, experts, and cases are some of the hottest topics in legal research today. They constitute a relatively new arsenal of tools that can help lawyers gauge the likelihood of success of their cases and evaluate or make settlement proposals. This ever-growing body

of state and federal statistics are colloquially referred to as 'legal analytics,' and all of the top legal research vendors offer their own versions and search capabilities.

The Cleveland Law Library subscribes to *Westlaw Legal Analytics* for our staff to use on behalf of our members. The Law Library's *Westlaw* content offers statistics on state and federal court judges, courts, attorneys, law firms, case types, and damage awards. As an example, *Westlaw* can generate a comprehensive judicial report containing tables, charts, and graphs that display various types of information about a judge, including:

· experience with different types of cases (e.g., labor, torts) by years, parties, attorneys and law firms;

- outcomes of their cases (e.g., settlement, dismissal, verdict, dispositive motion) by types of cases and the times it took to reach those outcomes;
- results for various types of motions (e.g., for dismissal, to strike, for summary judgment, in limine) by case type, year, and motion outcomes (e.g., granted, denied, vacated);
- precedents upon which a judge has relied;
- · expert challenges; and
- · appellate statistics (where applicable) by case types.

For law firms, Westlaw will compile graphical reports containing a variety of statistics, such as:

- experience in different types of cases by courts, roles, parties, judges, and dates
- outcomes of their cases (e.g., settlement, dismissal, verdict, dispositive motion) by types of cases and the times it took to reach those outcomes; and
- results for various types of motions (e.g., for dismissal, to strike, for summary judgment, in limine) by case type, year, and motion outcomes (e.g., granted, denied, vacated)

Although not all cases and courts are covered yet, *Westlaw* is continually adding new data all the time. If you are interested in legal analytics for one of your pending cases, please contact Law Library staff for assistance.



### HB7: REVISE PROBATE LAW, GUARDIANSHIP LAW, AND OHIO TRUST CODE

Effective on August 17, 2021, the Ohio Legislature enacted several changes to Ohio probate law, guardianship law and the Ohio Trust Code as part of <u>HB7</u>. A key change in the new law changes the process for making anatomical gifts (organ donation). Individuals can no longer make anatomical gifts in wills or living



wills. However, individuals can still register to become organ donors with the Ohio Bureau of Motor Vehicles, which maintains an Ohio Donor Registry. The law also outlines two other procedures, one of which can be utilized when someone is terminally ill or injured. 
